- FEDERAL JURISDICTION, *Younger v. Harris* 137
In the absence of bad faith harassment by state authorities, the mere showing of a chilling effect on first amendment freedoms held insufficient to warrant a federal injunction staying state criminal proceedings.

A federal court, sitting in diversity, held not bound by conflict of laws rules of the forum state when a false conflict is found to exist.
